On-site medical services

On-site medical services at the chemical site Leuna since 1916

For our customers, we will take on all occupational medical health services in accordance with Occupational Safety Law and German Social Accident Insurance (DGUV) provision 2.

We will carry out for your employees the examinations pursuant to all government or of the industrial professional regulations, e. g. including occupational health care (ArbMedVV dated 31.10.2013) or as aptitude test following the German Statutory accident insurance law (DGUV).

At present, we annually have approx. 15,000 aptitude tests and examinations for approx. 350 companies, administrations, and institutions and offer approx. 170 customers medical attendance.

We are directly located in the Leuna health center on the chemical site. This facilitates direct links to doctors from other specialized fields, including general medicine, internal medicine, gynaecology, ophthalmology, orthopaedics and surgery.

The same works doctor cares for the company's workforce over a long period of years. Results of examinations are all close at hand and thus facilitate quality and confidential assessments.

We are gladly at your disposal and offer you experienced and competent service for all questions concerning occupational health and health promotion.

On-site medical services

1. Main activities

Our on-site medical services offer the following:

Examination, assessment and advising of employees as well as compilation and analysis of examination results;

Advising of customer, in particular about:

- Planning, setting up and maintenance of plant facilities including social and sanitary facilities,
- Procurement of technical material and introduction of work processes,
- Selection and testing of preventative materials; physiological, psychological, ergonomic and hygienic questions, in particular work rhythm, hours and breaks, layout of work places, work processes and environment,
- Organization of first-aid in the work place,
- questions referring to change of work place and the incorporation of disabled workers into the work place;

Observation of works safety and accident prevention measures including:

- Visiting the work places regularly and informing the customer of any deficiencies found suggesting ways to eliminate such deficiencies and assisting in remedy implementation,
- Alerting the customer to effective use of protective equipment,
- Examining the causes of work-related illnesses, compiling and evaluating results and suggesting ways of combating these illnesses;

To see that all those employed in the company follow regulations concerning works safety and accident prevention, particularly with regard to health and safety; to see that regulations are implemented in the work place; to brief employees on the equipment and measures for reducing these dangers; to help in planning and training first-aiders and medical personnel.

2. Services offered

Additional services can be discussed with the on-site medical services department.

Checks according to the Regulation on the right to drive FeV for all motorised vehicles (bus, taxi, ambulance and fire service vehicles as well as for hazardous goods transporters);

Suitability for fire service;

Suitability for piloting motor boats;

Immunizations;

Follow-up checks for employees who were exposed to occupational carcinogens;

Examinations in accordance with requirements of laws regulating employment of minors.

3. Prevention within the company

Additionally, we therefore engage in preventive activities:

Health check campaign (Laboratory value analyses, Men's check, Colorectal cancer screening, Thyroid check, Pulmonary function test, Hearing exam, ECG, Stress-ECG);

4. Optional services as occupational health management or private service

Travel medicine consultations and examinations;

Athlete checkups;

Laboratory value analyses (i.e. Blood count, Blood sugar level, Cholesterol level, Thyroid test, Kidney test, Liver test, PSA test).

In addition to occupational health care, our on-site medical service offers travel medicine consultations and examinations as well as travel vaccination services. Appointments can be made either by phone or email. All travel vaccinations including yellow fever can be carried out. InfraLeuna is listed as one of the official yellow fever vaccination centers in Sachsen-Anhalt.

The on-site medical service of InfraLeuna offers physical fitness examinations for employees of InfraLeuna and the population. Appointments can be made either by phone or email.
